To offer amendments for the first time and then proceed to vote on those amendments requires the Board to do one of two things, and neither are optimum. Either we must vote without the benefit of advice from our staff, or we must obtain in a public setting advice that would otherwise be protected from disclosure by the deliberative process privilege. The privilege exists to ensure that such advice is candid and given without reservation.	е
Later references to voting contained in the FRN are appropriately conditioned with the word may.' However, the initial objective statement combined with the many occurrences of "may vote" causes the FRN to give the impression that voting is likely. While our procedures will permit voting, I understood the consensus of the Board at the latest gathering on the matter was that the most probable scenario would be deliberations followed by adjournment to notational voting.
