Revise the FRN as shown in the attached document. The revisions delete all references to a meeting and the Government in the Sunshine Act.

Justification

The Board Procedures specify that all public hearings shall be noticed as a combined meeting and hearing. However, in recent memory all events noticed as combined meetings and hearings have been executed as hearings only. The General Accounting Office found that the Board's practice regarding noticing may confuse the public and recommended that the practice be discontinued.

Further, a necessary predicate to making a combined notice has not been completed. Specifically, the Board procedures provide:

Combined Meeting and Hearing. When any hearing has a quorum in attendance, the hearing shall be considered a combined meeting and hearing, *and the procedures of a meeting specified above shall be followed.* (Italics added for emphasis)

The Board has not complied with the procedure for a meeting which provides, "The Board shall approve the meeting agenda by vote prior to giving notice, as required by 10 C.F.R. Part 1704." The Board has not approved a meeting agenda. Without an approved agenda the Board would be unable to execute a meeting because the meeting procedure specifies, "The Chairman shall conduct the meeting as prescribed in the agenda," and "The business of the meeting shall be limited to items listed on the agenda." Finally, the procedure for a meeting provides, "The public will be provided the opportunity to comment at open meetings." The proposed FRN and associated hearing agenda provide for public comment during the hearing portion of a combined event, but no provision has been made, and no notice is proposed for, public comment during a meeting portion of the event.
