On page 14, insert a new paragraph immediately following the title, "Safety in Design and Infrastructure":

Board Direction – The staff shall limit total work on WTP so as not to exceed 2.0 FTE, a reduction from approximately 3.4 FTE in the plan submitted to the Board (see Figure 3 on page 6). In executing the 2.0 FTE, the staff shall prioritize activities required by Policy Statement 6. If further prioritization is required, the staff shall next prioritize activities according to when the specific facility is expected to begin operations. For example, activities related to LAW should be prioritized over those related to HLW. The staff shall notify the Board of the activities turned off as a result of this direction.

#### Justification

The level of effort dedicated to WTP is excessive. Most of WTP will not operate for a decade or longer. Limiting the staff level of effort on WTP frees up staff resources for oversight of other DOE/NNSA work, work that potentially impacts the adequate protection of the public health and safety in the near term.
