I disapprove of this amendment for several reasons. First of all, the staff should have some flexibility in determining new activities as issues arise within the complex without having to go through an onerous approval process. There are mechanisms by which the staff keeps the Board apprised of any additions or modifications to the work plan and should the Board be uncomfortable with any of those, it could take action and has the mechanisms by which to do so. Introducing a new procedure through an amendment process is problematic.

Additionally, my input to the process that specifically focused on our statutory duty with regards to timely review and monitoring the design and construction of new facilities or modifications needed to accommodate new mission such as pit production is expressly taken out by this amendment. I believe this sends the wrong message to the staff as to the Board's role in these activities and it undercuts my role as a Board Member by targeting my comments for removal without justification for the change.
