As the author points out, this is a resubmittal of an amendment to the FY2014 staffing plan that did not pass.

I do not support this amendment. I do not believe DNFSB staff should review documentation associated with Design Agent weapons response assessments for technical accuracy and adequacy and develop appropriate advice to the Secretary of Energy. I believe these assessments of weapons response are the responsibility of the design labs, i.e., Los Alamos, Livermore, and Sandia. These design labs must certify the safety and surety of the nuclear weapons stockpile on an annual basis to the President and Secretaries of Energy and Defense. Once the labs determine the weapons response, the Board should provide oversight to ensure that Pantex has identified and adequate control set to support its assembly, disassembly, and dismantlement of weapons.


