Recommendation #6 from the Nuclear Regulatory Commission's Office of Inspector General (OIG) draft audit report of *DNFSB's Process for Developing, Implementing, and Updating Policy Guidance* states "Revise D-21.1 and OP-21.1-1 to incorporate OIG roles and responsibilities in the review of draft directives". The audit report text states "OIG's review and comment on a policy document would be limited to the detection of fraud, waste, and abuse, and not the enhancement of program efficiency...To remain independent and objective, OIG would not otherwise comment on the substantive content of the document, nor would it be permitted to concur nor object to the document."
