Justification

The amendment deletes the requirement for the General Counsel to attend entrance and exit conferences. Deleting the requirement does not prevent the General Counsel from attending. The GC should attend (or not attend) subject to the executive direction of the Chairman and the GC's own determination of the value added by being present.

The current language in the Directive amounts to an agency mandate requiring the GC to attend. Such a mandate needlessly restricts proper management of the agency. A conference for some recurring audits such as the OIG audit of purchase cards may not require the presence of the GC. Further, on some occasions the scheduling of a conference may be needlessly hindered when circumstances result in reduced OGC manning.

The Operating Procedure should specify normal conference attendees.
