OGC attorneys complete clearance and other paperwork as necessary, make travel arrangements, coordinate with Technical Staff, review documents/packages that will be provided to Board Members, attend pre-briefings to the Board, and assist Technical Staff in post travel trip report preparation. Additionally, the General Counsel must provide concurrence on all Board Member, Senior Executive, and business class travel in accordance with Board Operating Procedures OP-221.1-1, *Official Travel Operating Procedures*.

## Justification

The Board approved an identical change in language to the 2016 work plan by vote on Doc#2015-168C, archived on 10/14/15. Despite the change made by the Board to the 2016 work plan, the proposed language for the 2017 work plan contains the sentence the Board removed a year ago. That practice should be discouraged.
